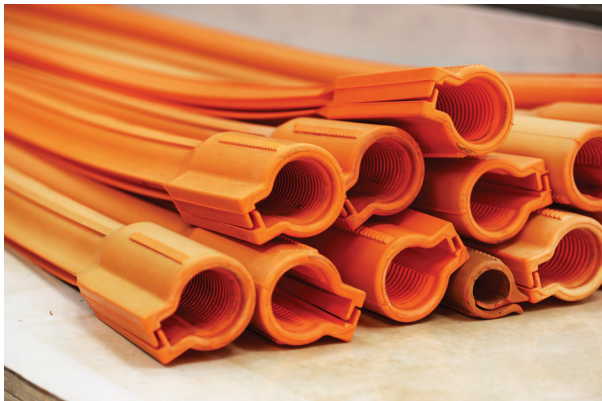

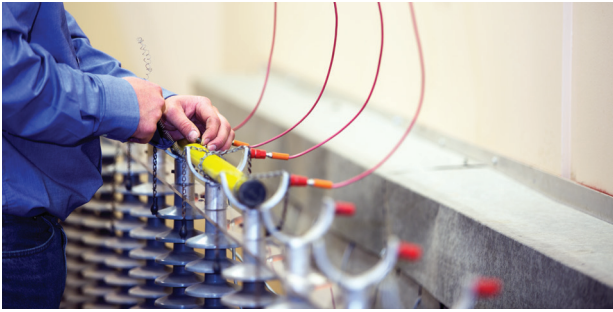

Ensuring Safety

Protective Equipment Testing Services at the Lower Colorado River Authority (LCRA) ensures protective equipment is in good condition to help electrical workers perform their jobs safely.

LCRA Protective Equipment Testing Services provides customers across Texas with laboratory and on-site testing. LCRA employees have tested protective equipment for more than 50 years.



Accreditation

LCRA's Protective Equipment Testing (PET) Lab is a state-of-the-art facility accredited by the Association of North American Independent Laboratories (NAIL). PET Lab technicians perform tests in accordance with American Society for Testing and Materials (ASTM), Institute of Electrical and Electronics Engineers (IEEE), and Occupational Safety and Health Administration (OSHA) standards.



Service and Testing



Regularly servicing and testing gloves and other personal protective equipment are critical to ensuring employee safety.

Customers can purchase new or replacement equipment from the PET Lab, including rubber goods, hot sticks, grounding equipment and accessories.

ASTM Retest Intervals

Equipment Type	Retest Intervals*
Insulating gloves	Before first use and every six months after use begins.
Insulating sleeves	Before first use and every 12 months after use begins.
Rubber blankets	Before first use and every 12 months after use begins.
Rubber line hoses and covers	When there is reason to believe item's integrity may have been compromised.
Plastic guards	When there is reason to believe item's integrity may have been compromised.
Insulated jumpers	When there is reason to believe item's integrity may have been compromised.
Hot stick and live-line tools	Before first use and every two years after use begins.
Personal protective grounds	When there is reason to believe item's integrity may have been compromised.

**This is the maximum length of time allowed. Work practices and company policies may require more frequent testing.*
